### ***Opioid Interactions and New Opioids***

At the end of this session, participants will be better able to discuss the growing evidence that a patient's individual genetic control of opioid metabolism affects its efficacy, potential drug interactions and adverse effects; predict potential reactions and interactions; list new opioids that include opioid metabolites that do not require metabolism for activation as well as new formulations of older opioids to increase drug misuse deterrence.

### ***Neuroanatomy for Spinal Cord Stimulation (SCS)***

Giancarlo Barolat MD

At the end of this session, participants will be better able to outline the anatomy and physiology of the intraspinal structures as related to SCS; differentiate responses to neurostimulation between various intraspinal structures; describe the characteristics of the thoracic spine and spinal cord as related to SCS, as well as the cervical spine and spinal cord and the cauda equine/conus medullaris; formulate strategies for implantation of SCS devices.

### ***Preoperative, Postoperative Considerations, Complication Management of SCS***
